

RECTOR OF THE UNIVERSITY OF SZCZECIN

EXECUTIVE ORDER NO 28/2020

dated March 11th, 2020

Concerning the prevention of the spread of the SARS-CoV-2 virus among the academic community of the University of Szczecin

In accordance with Article 23, Section 1. of the Act of Parliament issued July 20th, 2018 *Law on Higher Education and Science* (Journal of Laws dated 2020, position 85 with changes) and the Act of Parliament dated March 2nd, 2020 on special measures pertaining to the prevention, countering and elimination of COVID-19, other infectious diseases and crises arising from them (Journal of Laws dated 2020, position 374) I hereby order the following:

§ 1.

1. University classes, laboratories, lectures and seminars involving direct contact with the students, PhD students and post-graduate courses participants are suspended.
2. All University libraries are closed for the users.
3. Geological Museum and other units of the University of Szczecin available to the public are closed.

§ 2.

1. All events available to the public: conferences, symposia, lectures, sports events and other gatherings organized on the premises of the University of Szczecin, including those organized by third parties, are cancelled.
2. Domestic and international duty trips of students, PhD students and University of Szczecin staff are suspended.
3. Participation in domestic and international conferences of students, PhD students and University of Szczecin staff is suspended.
4. Visits of foreign guests including the employees of other colleges and universities, students, PhD students and guests invited by the University of Szczecin are suspended.
5. Accommodating new guests and residents at the University of Szczecin Halls of Residence and its other buildings is suspended. Visits there are banned

In a separate announcement, the Rector of the University of Szczecin will specify ways in which the contents of suspended courses as outlined in their syllabi are to be realized and their learning outcomes confirmed by means of e-learning.

§ 4.

1. Suspending classes, laboratories, lectures and seminars does not mean that the University is closed.
2. The schedule of the election campaign activities at the University of Szczecin is not affected and the University Electoral Committee carry out their statutory duties.
3. All University bodies including: the Senate, University Council, University Research Council, Institute Councils, Teaching Councils operate without let or hindrance.

§ 5.

1. The announcements issued by the services responsible for public health should be monitored, in particular those issued by the Chief Sanitary Inspectorate www.gis.gov.pl and those issued at the recommendation of the Minister of Science and Higher Education.
2. The recommended channels of communication within the University of Szczecin are emails and telephones. It is recommended that personal contacts be limited.

§ 6.


In circumstances not specified in the present order, the Rector may take individual decisions at his discretion.
